The Executive Council also noted the reply received from the Principal, Panskura Banamali College against the clarification sought for by the University as per the decision of the EC in its meeting dated 30.10.2013 regarding the selection process of the contractual engagement of Dr. Syed Mahamud Hossein, first man of the panel recommended by the Standing Committee for the post of Secretary, Council of Undergraduate Studies of Vidyasagar University, during the period 01.08.1998 to 15.03.2002. The Executive Council noted further that the service of Dr. Hossein at Panskura Banamali College in the contractual manner was not continuous.
