" A disciplinary authority having formed the opinion that a charge-sheet may be issued, it is open to him to include therein such other allegations of misconduct/misdemeanor which would warrant a proper investigation. There is no reason to hold that the charge-sheet suffers from a defect.

The writ petition, being devoid of merit, fails and is dismissed. The time for the petitioner to respond to the charge-sheet is extended by 14 days from date."

<u>Resolution:</u> The Executive Council of Vidyasagar University noted the letter bearing D.O. No. F.13-1/2000(EA/ENV/CIS-I) dated 08.08.2014 received from the Secretary, University Grants Commission, New Delhi stating that the Hon'ble Supreme Court of India in its order dated 06.12.1999 in W.P. No. 860/1991 has directed that appropriate steps be taken to introduce

environmental studies course in all Universities and affiliated colleges. The UGC in pursuant to this order had designed a six month module syllabus for environmental studies for undergraduate courses for all branches of higher education to be compulsorily implemented and the same was communicated to all Universities for strict compliance. The UGC has been repeatedly reminding Vidyasagar University for the said compliance. In this connection he has requested the University to apprise them regarding implementation of the direction of the Hon'ble Supreme Court in the current academic session.

After thorough discussion on the letter submitted by the Secretary, University Grants Commission, New Delhi pertaining to implementation of the direction of the Hon'ble Supreme Court regarding introduction of Environmental Studies Course in Vidyasagar University and its affiliated colleges in the current academic session, it was resolved that the Secretary, Council for Undergraduate Studies of this University be requested to prepare a compliance report in this regard and the said report be placed in the next meeting of EC for further action.
