Nandi, Registrar(Actg.), Professor Tirthankar Das Purkayastha, Dean (Actg.), Faculty Councils for Postgraduate Studies in Arts & Commerce did not want to participate in this regard and wanted to leave the meeting. The member of the Executive Council requested them to continue to stay in the meeting. But gave them liberty to abstain from discussion in this regard. The Hon'ble Vice-Chancellor, Registrar(Actg.) and Dean(Actg.), Faculty Councils for Postgraduate Studies in Arts & Commerce thereafter abstained from any further discussion taken upon the issue.

After thorough discussion on the letters submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of this University, now under suspension, pertaining to her being allowed to join her regular duties as a permanent Assistant Professor in the Department of English of this University and after careful consideration of the action taken by the University authority in filing an application before the Hon'ble High Court, Calcutta for extension of time for completion of the disciplinary proceedings and as the said application has already been listed on 01.06.2015 at Serial Number 16, it was resolved that Dr. Dutta (Chaudhuri) be not permitted to join her regular duties at Vidyasagar University till such time the matter is heard and orders are passed in the said application. Resolved also that the entry of Dr. Datta (Chaudhuri), currently under suspension, in the University premises on 7th May, 2015 without the prior permission of the University authority be sharply disapproved.

06.(n) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/UE/1742/2015 dated 29.04.2015 submitted by the University Engineer pertaining to construction of Surface Drain for discharging the surface water including rain water of newly constructed Science Building (Einstein Building) as well as Auditorium Complex.

Resolved also that the resolutions taken in this regard be confirmed.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. VU/UE/1742/2015 dated 29.04.2015 submitted by the University Engineer along with the supporting documents and the inspection report of the Expert members of the Engineering Strengthening Committee stating that as suggested by the Expert of the Engineering Strengthening Committee of Vidyasagar University it is urgently required one surface drain for discharging the surface water including rain water of newly constructed Science Building (Einstein Building) as well as Auditorium Complex of this University. The Executive Council also noted that the said work may be executed through the running contractor within the approved fund proposed by the University Engineer.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing Memo No. 403(27)-Edn(U)/1U-30/15 dated 24.04.2015 submitted by the Deputy Secretary to the Government of West Bengal, Higher Education Department stating that in compliance to the guidelines as communicated by the UGC based on the Judgement of the Hon'ble Supreme Court of India all higher education institutions under the control of the Higher Education Department, Government of West Bengal are requested to implement some steps stated in the said letter. The Executive Council also noted the detailed steps specified in the letter to be implemented in this University for Transgender(TG) under general category.

After thorough discussion on the letter submitted by the Deputy Secretary to the Government of West Bengal, Higher Education Department pertaining to implementation of some steps for Transgender(TG) under general category in all higher education institutions under the control of Higher Education Department, Government of West Bengal, it was resolved that the steps specified by the Higher Education Department be implemented in this University for Transgender(TG) under general category. Resolved also that Professor Tirthankar Das Purkayastha be requested to do the needful in this regard as Convener.

06.(p) To place before the Executive Council of Vidyasagar University, the note dated 18.05.2015 prepared and submitted by the University Engineer pertaining to preparation of comparative statement for selection of lowest bidder for supply of 10 KVA sound proof D.G. Set for V.C. Bunglow/Rangamati Guest House and also preparation of the estimate for installation and commissioning of the said DG Set.

Resolution: The Executive Council of Vidyasagar University noted the note dated 18.05.2015 prepared and submitted by the University Engineer along with the comparative statement for selection of the lowest bidder for supply of the 10 KVA sound proof D.G. set as a standby arrangement which may be shifted to other location in future as per the requirement and presently to be installed for the Rangamati Guest House/ Vice-Chancellor's Bunglow and also preparation of the estimate amounting to Rs. 4,74,355/- (Rupees four lacs seventy four thousand three commissioning of hundred fifty five) only for installation and said DG set in the University.



After thorough discussion on the note prepared and submitted by the University Engineer pertaining to preparation of comparative statement for selection of lowest bidder for supply of 10 KVA sound proof D.G. Set presently to be installed for Rangamati Guest House/ Vice-Chancellor's Bunglow and also preparation of the estimate for installation and commissioning of the said DG Set, it was resolved that the comparative statement prepared for selection of lowest bidder for supply of the said DG set be accepted. Resolved also that the estimates amounting to Rs.4,74,355/(Rupees four lacs seventy four thousand three hundred fifty five) only prepared by the University Engineer for installation and commissioning of the DG set in this University be approved. Resolved further that the said DG set be used in the University campus multi-purposely.

06.(q) To place before the Executive Council of Vidyasagar University, the note sheet dated 13.05.2015 prepared and submitted jointly by the Deputy Registrar, Programmer and Information Scientist pertaining to imposition of security measures over pre-printed stationery of Marksheet, Admit Card, Registration Certificate & Diploma Certificate etc. and also the budget estimate for this purpose.

Resolution: The Executive Council of Vidyasagar University noted the notesheet dated 13.05.2015 prepared and submitted jointly by the Deputy Registrar, Programmer and Information Scientist along with the budgetary provision for imposition of security measures over pre-printed stationery of Marksheet, Admit Card, Registration Certificate & Diploma Certificate etc. The Executive Council also noted the budgetary provision prepared for this purpose.

After thorough discussion on the Notesheet prepared and submitted jointly by the Deputy Registrar, Programmer and Information Scientist pertaining to imposition of security measures over pre-printed stationery of Marksheet, Admit Card, Registration Certificate & Diploma Certificate etc. and also the budget estimate for this purpose, it was resolved that the proposal for imposition of security measures over pre-printed stationery of Marksheet, Admit Card, Registration Certificate & Diploma Certificate etc. be accepted as it is very urgent. Resolved also that the budgetary provision prepared and submitted for this purpose be approved and the amount of which to be noted in the next meeting of the Finance Committee. Resolved further that a work order for the said job be issued to the existing approved vendor of Vidyasagar University "M/s. Quality Forms Pvt. Ltd." for printing such confidential stationery on urgent basis.

After thorough discussion on the letter dated 14.05.2015 submitted by Mr. Budh Bahadur Lama, Assistant Professor (on lien), Department of Political Science with Rural Administration of this University pertaining to reappeal for extension of leave with lien for another three months with effect from 02.06.2015, it was resolved that the prayer of Mr. Lama regarding extension of leave with lien be regretted. Resolved also that if Mr. Lama fails to return back to this University for joining the post on or before 02.06.2015, the said post be declared as vacant and further process for filling up the said post be taken as per the norms of the University. Resolved also that regarding nomination of experts in the Selection Committee for recruitment of the said post, the matter be left to the Hon'ble Vice-Chancellor for necessary action.

Resolution: Consideration of the item was deferred.

Registration

11. To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/DR/310/2015 dated 13.05.2015 prepared and submitted jointly by the Inspector of Colleges and the Deputy Registrar of this University pertaining to not allowing of registration of 10 (ten) candidates of five undergraduate colleges for the session 2014-2015.

Resolution: The Executive Council of Vidyasagar University noted the letter jointly submitted by the Inspector of Colleges and the Deputy Registrar of Vidyasagar University stating that five undergraduate colleges, viz. Bajkul Milani Mahavidyalaya, Prabhat Kumar College, Contai, Bhatter College, Dantan, Subarnarekha Mahavidyalaya and Chandrakona Vidyasagar Mahavidyalaya have submitted 10 (ten) new registration forms after getting the notice dated 23.04.2015. As per the decision of the Committee these newly submitted forms should not be allowed for registration as adviced by the Hon'ble Vice-Chancellor.

After thorough discussion on the letter jointly submitted by the Inspector of Colleges and the Deputy Registrar of this University pertaining to not allowing of registration of 10 (ten) candidates of five undergraduate colleges, viz. Bajkul Milani Mahavidyalaya, Prabhat Kumar College, Contai, Bhatter College, Dantan, Subarnarekha Mahavidyalaya and Chandrakona Vidyasagar Mahavidyalaya for the session 2014-2015, it was resolved that as advised by the Hon'ble Vice-Chancellor and duly recommended by the Committee the new registration forms (10 Nos.) submitted by the above mentioned colleges not be allowed for registration for the academic session 2014-2015 as they have submitted the forms beyond the dates stipulated by the University in this regard.

12. To place before the Executive Council of Vidyasagar University, the letters received from the Director of Public Instruction, Government of West Bengal, Education Directorate, Bikash Bhavan pertaining to inspection at Govt. General Degree Colleges in the district of Purba & Paschim Medinipur for assessing feasibilities of the introduction of both honours and general courses in different subjects of Science and Humanities at UG level with effect from the academic session 2015-2016.

Resolution: The Executive Council of Vidyasagar University noted the letters received from the Director of Public Instruction, Government of West Bengal, Education Directorate stating that the Govt. in the Higher Education Department, West Bengal has intended to introduce the honours and pass courses in the Govt. General Degree Colleges at Gopiballavpur - II, Dantan - II, Mohanpur, Sahid Matangini Hazra Women's College at Nimtouri, Kharagpur - II and Keshiary in the districts of Purba and Paschim Medinipur with effect from the session 2015-2016. In this context, he has requested the University authority to take necessary steps for inspecting such colleges for evaluating existing infrastructure and other issues of relevance towards the introduction of the courses at undergraduate level.

After careful consideration of the letters jointly submitted by the Director of Public Instruction, Government of West Bengal, Education Directorate, Bikash Bhavan pertaining to inspection at Govt. General Degree Colleges in the district of Purba & Paschim Medinipur for assessing feasibilities of the introduction of both honours and general courses in different subjects of Science and Humanities at UG level with effect from the academic session 2015-2016, it was resolved that necessary affiliation be extended to the colleges as stated above for starting the admission process for the session 2015-2016 for this purpose. Resolved also that the Inspector of Colleges be requested to inspect all the colleges as per the norms of the University and to submit the detailed reports in this regard separately during the admission process of the colleges for the session 2015-2016.
