

Resolution of the Ph.D. Meeting in Commerce held on 20.08.2015 :

1. The proceedings of the earlier meeting held on 16th June, 2015 has been read and confirmed.
2. Mr. Saibal Mukhopadhyay had presented his pre-submission seminar in front of Ph.D. Committee in Commerce. There were some suggestions as follows -
 - a) Number of literature review should be increased
