

Resolution of the Ph.D. Meeting in Commerce held on 09.2.2016 :

In absence of our Hon'ble Vice Chancellor, the Dean faculty of Arts and Commerce is requested to chair the meeting.

1. The proceedings of the earlier meeting held on 07.01.2016 has been confirmed.
2. Mr. Santu Charan Das had presented and his pre-registration seminar in front of the Ph.D. Committee in Commerce. There were some suggestions as follows :
 - a) Group of individual factors impact on capital structure to be examined, but not group individual factors.
 - b) In objectives, one objective will be to make an attempt to determine optimal capital structure.
 - c) The title of the Ph.D. work to be change as 'Determining optimal Capital Structure : A Study of BSE 500 Companies'.Mrs. Srimoyee Datta had presented her Pre-registration on Seminar in front of the Ph.D. Committee in Commerce. There were some suggestions as follows :
 - a) Comparative analysis of Private MFIs with other MFIs to be done.
 - b) In Chapter Plan, Chapter 2's title should exclude the term women empowerment.Mr. Wakil Hossain had presented his Pre-registration seminar in front of the Ph.D. Committee in Commerce.

There was one suggestion to change the title of the study as 'A study on Financial inclusion in West Bengal with special reference to the Muslim Community in Malda District'.


Mr. Tamaghana Mondal had presented his Pre-registration seminar in front of the Ph.D. Committee in Commerce. There were some suggestions as follows :
 - a) Objectives 3 is to be excluded i.e. comparison of venture capital in India with abroad.
 - b) Study should be held only on secondary data and primary data to be excluded.
3. In Misc. Mr. Rana Pratap Pal has presented his pre-submission seminar again (given earlier on 07.11.2016) in front of the Ph.D. Committee in Commerce. The was one suggestion to do more statistical analysis of the data and after incorporation of suggestion he may be allowed to submit his thesis. Panel of adjudicators of Mr. Rana Pratap Pal was placed by his supervisor (Dr. Amit De of Contai P.K.College) and the same was approved by the Ph.D. Committee.

Mr. Dipak Kundu is worked under the supervision of Dr. Abhijit Sinha w.e.f. 10.10.14 in the title of 'A Study on lending trends of Commercial Banks in India with Special reference to priority Sector'.
