## Resolution

The Court of Vidyasagar University noted the letter bearing No. 5136-G dated 13.12.2017 received from the O.S.D. & E.O. Special Secretary to the Governor of West Bengal, Raj Bhavan, Kolkata stating that the Governor of West Bengal & Chancellor of Vidyasagar University is pleased to agree to preside over the Twentieth (20th) Convocation of Vidyasagar University on 08.03.2017.

After thorough discussion on the letter received from the O.S.D. & E.O. Special Secretary to the Governor of West Bengal, Raj Bhavan, Kolkata regarding holding the Twentieth (20th) Convocation of Vidyasagar University on 08.03.2018, it was decided that the Twentieth Convocation of Vidyasagar University be held on 08.03.2018 duly affirmed by His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University.

#### Resolution

The Court of Vidyasagar University noted that the Executive Council of Vidyasagar University in its meeting held on 29.12.2017 discussed the matter regarding nomination of the name of the Guest-in-Chief who will deliver the Convocation Address and also conferment of the honorary degrees (honoris causa) in the Twentieth (20th) Convocation of Vidyasagar University scheduled to be held on 08.03.2018 at the University Auditorium "Vivekananda Sabhagriha" and constituted a Search Committee to suggest the name of the eminent persons who will be the Guest-in-Chief and also the name of the recipients who will be conferred the honorary degree (honoris causa) of D.Sc. and D.Litt, of Vidyasagar University in the Twentieth(20th) Convocation of Vidyasagar University. The Executive Council in its aforesaid meeting also decided that regarding formation of the said Search Committee, the matter be left to the Hon'ble Vice-Chancellor of this University for necessary action.
