Proceedings of the Emergency DC (English) meeting of 21.09.2017

The meeting started around 2.30 pm with all the members being present. Dr. Datta (Chaudhuri) started making audio-visual record of the proceedings and as the Head along with the members protested, she started shouting that she would do whatever she liked. She insisted that unless the authorities issued specific instructions in writing against her private recording she would continue with this practice. She also threatened the members of the DC with dire consequences if the administration took any measures against her. The members felt that the matter needed to be sorted out by the authorities and sought the intervention by the administration. The administration immediately responded by sending the EC member, Dr. Papia Gupta, HoD, Department of Philosophy and the Life World, as observer. The meeting started again in the presence of the observer. HoD requested the members to suggest the convenient dates for CBCS and Communicative English classes. As some teachers offered their dates, Dr Datta (Chaudhuri) was asked to give hers. Dr Datta (Chaudhuri) sarcastically remarked that she would wait for the 'leftovers' after all her colleagues had given their dates. The Head protested against such insinuation. Dr Datta (Chaudhuri) replied that HoD was talking like a 'maidservant' and that he would be rewarded by being elevated to the post of a Professor by the authority for his subservience. All the members including the observer took serious exception to the remark of Dr Datta (Chaudhuri) and insisted that the comment be withdrawn. Dr Datta (Chaudhuri), however, refused to withdraw her remark and declared that she would stand by what she said.

All the members felt that the meeting could proceed no further in view of such explicit insult to the Chair. The members requested the observer to report the whole matter to the EC.

Resolutions: Resolved that the meeting be postponed.

Resolved that the agenda for the present meeting be taken up in the next DC meeting to be held on 23.09.2017.

Resolved further that the authorities be requested to provide an observer for the meeting to be held on 23.09.2017.
