

Terms & conditions :

1. The Ph.D. Committee will normally function for a term of four(4) years w.e.f. 21.05.2014.
2. Presence of fifty percent(50%) of the members in a meeting of the Ph.D. Committee including at least one external expert but excluding the supervisor(s), invitee members, shall constitute the quorum. [Provided that the presence of external members in a meeting shall not be mandatory for consideration of routine matters like determination of number of available positions/seats in a year, scrutiny of application forms, organizing Entrance Test and Interviews, finalization of panel including merit list, and preparation of list of paper setters, moderations and examiners for Entrance Test and Semester(end) Examinations.
3. The supervisor(s) concerned shall be invited to participate as invitee member(s) without voting right in connection with the supervision work of the scholar(s) concerned.
4. In absence of the Vice-Chancellor, the Dean of the faculty concerned shall chair the meeting. In absence of both the Vice-Chancellor and the Dean, the members shall select a Chairman not below the rank of a Professor from among themselves.
5. The Ph.D. Committee shall meet at quarterly intervals in a year or more frequently, if necessary.
