No: VU/Dean of Sc/I-1099/18 dated 05.12.2018 and that the note of the Hon'ble Vice-Chancellor on the body of the notesheet (Ref. No: VC/6486/2018 dated 05.12.2018). The name was sent to the Secretary, Ph.D. Committee in Anthropology from the Ph.D. Section, VU along with the application forms of two (02) candidates namely Ms. Samarpita Paul and Mr. Pabitra Paul.

Through the note sheet, it has been requested that the concerned candidates may be allowed provisionally to enroll themselves in the Ph.D. programme of Vidyasagar University immediately. Professor K.
