Agenda 1: To confirm the proceedings of the earlier meetings.

Resolution: Resolved that proceedings of the earlier meetings held on 13th Jan., 2022 and 3rd Feb., 2022 (emergent meeting) has been confirmed.

Agenda 2: To discuss on the progress of webinar.
